

**RESOLUTION # 2016-129**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SURPRISE, ARIZONA APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH MARICOPA COUNTY IN THE AMOUNT OF \$136,692 TO FACILITATE COMPLETION OF THE APPROVED FY2017 ACTIVITIES WITH HOME GRANT FUNDS.**

**WHEREAS**, pursuant to Arizona Revised Statute §11-951, *et seq.*, the City of Surprise has the authority to enter into intergovernmental agreement with other governmental entities for the purposes set forth within;

**WHEREAS**, the Cities and Towns of Avondale, Chandler, Gilbert, Glendale, Peoria, Scottsdale, Surprise, Tempe, and Maricopa County have previously entered into an Intergovernmental Agreement (IGA) to form the Maricopa HOME Consortium (HOME Consortium IGA) to receive, distribute, and administer HOME Investment Partnerships Funds (HOME);

**WHEREAS**, the United States Department of Housing and Urban Development and Maricopa County Consortium has allocated the City of Surprise \$136,692, to complete approved Major Rehabilitation projects to help low income residents of Surprise; and

**WHEREAS**, the City of Surprise Administrative Policies requires the approval of the Mayor and Council to enter into Intergovernmental Agreements of this nature.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Surprise, Arizona, as follows.

**Section 1.** The Intergovernmental Agreement between the City of Surprise and Maricopa County, HOME Investment Partnerships Program, attached as Exhibit A, is approved.

**Section 2.** The City is hereby authorized to accept grant funds in the amount of \$136,692 in FY2017 from Maricopa County for the Neighborhood Revitalization Fund.

**Section 3.** The City Manager, or his designee, is hereby authorized to execute and submit all documents and other necessary or desirable instruments in connection with said agreement.
